THE GRAND JURY, for the County of Limestone, State of Texas, duly selected, impaneled, sworn, charged, and organized as such at the June Term, A.D. 2009 of the 77<sup>th</sup> Judicial District Court for said County, upon their oaths present in and to said court at said term that Reginald Clark Hereinafter styled Defendant, on or about the 13th day of July A.D. 2004, and before the presentment of this indictment, in the County and State aforesaid, did intentionally and knowingly then and there unlawfully appropriate, by acquiring or otherwise exercising control over, property, to-wit: United States currency, of the value of \$100,000.00 or more but less than \$200,000.00 from Polly Prestwood and Henry Prestwood, the owners thereof, who were then and there elderly individuals, without the effective consent of the owners, and with intent to deprive the owners of the property

COUNT TWO

And it is further presented in and to said court, that the said Defendant, on or about between the dates of the 6<sup>th</sup> day of February 2004 and the 13th day of July A.D. 2004 and before the presentment of this indictment, in the County and State aforesaid, did then and there intentionally and knowingly unlawfully appropriate, by acquiring or otherwise exercising control over, property, to-wit: United States currency, of the value of \$200,000.00 or more from Polly Prestwood and Henry Prestwood, the owners thereof, without the effective consent of the owners, and with intent to deprive the owners of the property pursuant to one scheme or continuing course of conduct.

**CONDITIONS OF BOND**

As a condition of bond, the defendant is ordered as follows:

**Conditions with alleged victim (CCP 17.40-17.41)**

Defendant shall not communicate with any alleged victim as named in the indictment; go within 1,000 feet near alleged victim's residence, school, or other location where victim is located.

**Home Curfew (CCP 17.43)**

Defendant is to submit to home curfew. Defendant is to remain at his/her residence between the hours of 7:00P.M. and 7:00A.M. each day, unless otherwise directed by the Limestone County Community Supervision and Corrections Department for employment purposes.

**Conditions Related to Drug and Alcohol Testing (CCP 17.44)**

Defendant shall submit to random drug testing at the discretion of the Limestone County Community Supervision and Corrections Department. Drug testing will be done at defendant's expense.

Defendant shall abstain from using any alcohol, illegal or controlled substances.

Defendant must report once a month to the Limestone County Community Supervision and Corrections Department.

**Conditions requiring Motor Vehicle Ignition Interlock Device (Defendant charged with subsequent offense under 49.07 and 49.08 Texas Penal Code (CCP 17.441))**


Defendant shall have installed on the motor vehicle owned by defendant or driven by defendant, a device that uses deep lung breath analysis to make impractical the operation of a motor vehicle if ethyl alcohol is detected in the breath of the operator. The device shall be installed at the defendant's expense before the 30<sup>th</sup> day after the date the defendant is released on bond.

Defendant shall not operate any vehicle unless it is equipped with a device that uses deep lung analysis to make impractical the operation of a motor vehicle if ethyl alcohol is detected in the breath of the operator.

The Limestone County Community Supervision and Corrections Department shall verify that the interlock device is installed and shall monitor its function.

CHARGE: Misapplication of Fiduciary Property TPC 32.45

IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

THE GRAND JURY, for the County of Limestone, State of Texas, duly selected, impaneled, sworn, charged, and organized as such at the June Term, A.D. 2009 of the 77<sup>th</sup> Judicial District Court for said County, upon their oaths present in and to said court at said term that Reginald Clark Hereinafter styled Defendant, on or about between the dates of the 6<sup>th</sup> day of February 2004 and the 13<sup>th</sup> day of July A.D. 2004, and before the presentment of this indictment, in the County and State aforesaid, then and there intentionally, knowingly, or recklessly misapply property, to-wit: United States Currency, of the value of \$200,000.00 or more, that the said defendant held as a fiduciary or as a person acting in a fiduciary capacity, but not as a commercial bailee, contrary to an agreement under which the said defendant held the property, and in a manner that involved substantial risk of loss of the property to Polly Prestwood and Henry Prestwood, the owners of said property, and the person(s) for whose benefit the property was held, by converting the United States currency to the use or benefit of the said Defendant, pursuant to one scheme or continuing course of conduct.


